At your request, we are providing you with the enclosed Petition for Noisy Animal(s). We encourage you to contact your neighbor in an attempt to find a solution to the animal disturbance before filing the petition.

The petition is self-explanatory and is to be returned to our office after being completed. All witnesses must include their first and last names, full MAILING address, and home telephone number.

Separate letters stating the date(s) and time(s) the disturbance(s) has occurred may be returned with the petition. The letter(s) may state such facts as the affect of the disturbance on your health, sleep habits, nervous problem, and any contact with the animal owner.

When we receive the completed petition, a letter will be mailed to the animal owner informing them of the allegation and stating they have three (3) days to take the necessary action to ensure that the alleged violation does not continue. IF CORRECTIONS ARE NOT MADE, YOU ARE REQUIRED TO INFORM THIS OFFICE. At that time an Animal Control Officer will be assigned to make a field investigation. Depending upon the field investigation, further action may result. If YOU do not contact this office regarding the continued disturbance within six (6) months from the date on the petition, your complaint will be CLOSED and you will be required to file a new complaint/petition.
